I. Call to Order

James Powell called the meeting to order at 2:06 p.m. He welcomed everyone and asked for introductions.

II. Resource Persons

Mr. Powell identified Behavioral Science Research (BSR) staff as resource individuals.

III. Review/Approve Agenda

The committee reviewed the agenda. John McFeely requested to defer the Update on Habitat for Humanity to the February meeting. Mrs. Meizoso indicated Alecia Apfel wanted to make a presentation on Housing Stability Data under standing business. The committee approved the agenda as discussed.

VII. Standing Business

- Housing Opportunities for Persons Living with AIDS (HOPWA) Programs Update

Roberto Tazoe

There have been no changes since that last meeting; the Long Term Rental Assistant (LTRA) program is on client number 225. The STRMU program is still open but the feasibility of continuing the program in light of funding cuts next year will need to be examined. It appears that the program will lose five percent of its allocation next year which is between \$500,000-\$700,000.

Life Quest is in the permitting process. A collaboration between various departments within the City of Miami will allow the project to have a larger pool of developers.

BAME is waiting for the developer to apply for tax credits.

- Partnership Report James Ausborn

James Ausborn reviewed the Partnership report (copy on file).

- Resource Guide for Housing

Marlen Meizoso

Motion: Passed

Mrs. Meizoso reviewed the current housing resources on aidsnet.org and some suggested additions from the County's Affordable Housing page (copies on file). The link from the Affordable Housing page will be placed under Affordable Housing. In addition, a notation that the link is updated regularly will be added. The HAND's programs fliers will be placed under Homeless Assistance/Prevention and HAND will be spelled out. The HAND program requires registration in the Homeless system. The committee had several questions on the program so it was suggested they make a presentation. In February, staff will invite the HAND program to make a presentation to the committee.

Mr. McFeely indicated Trinity Cathedral Church offers some limited housing assistance through the Episcopal Church's discretionary fund for HIV/AIDS. Clients need to directly contact the church for assistance. St. Andrew's has a similar program. Additionally, Catholic Charities has a similar program.

- Housing Stability Data

Alicia Apfel

Alicia Apfel reviewed some Housing Stability data provided by BSR and from the Housing Needs Assessment (copy on file) at the last meeting. Households at 100-135% FPL (2016) have a larger rent burden based on 2017 fair market rates. These households spent over 57% on rents. There is a correlation between suppressed viral load and housing status. Improvements in housing stability would lead to reduced viral loads and less transmission. Money saved from care and treatment could be reinvested into additional short term housing assistance. Mr. Williams indicated that there was discussion regarding housing and prevention at the Prevention Meeting but Ryan White is not allowed to pay for housing. Ms. Apfel also reviewed the Getting to Zero Task Force matrix (copy on file) which indicated some recommendations to expand the housing available for PLWHAs (copy on file). Discussion on these goals will take place at the January 4th Getting to Zero committee meetings. Anyone interested in attending should contact Hardeep Singh at BSR to RSVP. Mrs. Meizoso indicated she would send out a reminder for that meeting to the committee.

VIII. New Business.

- January Invitation to Committee Meeting

Mrs. Meizoso reminded the committee that a motion was made last month to invite a deputy mayor and aides from Senator Rene Garcia's office to the January meeting. There are four deputy mayors in the County, and the deputy mayor who deals with housing issues would be Russell Benford. Senator Garcia has two legislative aides who may be invited. The committee agreed that Mr. Benford and the two aides should be invited to the meeting. The committee reviewed how the January meeting would be structured. Alicia Apfel will make a short presentation using the Needs Assessment presentation she made for the Partnership, along with some financial burden of housing data, and data that was included in the letter to the commissioners. Ms. Apfel requested that additional data be provided to her from BSR if it is available.

Motion to provide Alicia Apfel with summary data on cost of providing Ryan White Program care to homeless and non-homeless PLWHA in care, and on income differences between homeless and non-homeless Ryan White Program clients.

The committee would like the invitees to answer what can be done as individuals and as a committee to support efforts for HIV housing and what strategies (current and future) are being implemented in the County. The motion made last month did not indicate the method of how to communicate with the invites. Staff was authorized to draft appropriate letters.

Motion to authorize staff to issue written invitations to deputy mayor Russell Benford and aides from Senator Rene Garcia's office to the January 19th Housing Committee meeting.

Pauline Clarke-Trotman announced that tomorrow there is a homeless memorial candlelight ceremony being held for 142 homeless individuals who have passed away. The memorial will be from 11:30 a.m. to 12:30 p.m. in front of the fountain in the Government Center.

John McFeely announced that the Miami Shores Presbyterian Church is having a free luncheon on Sunday, December 25, 2016 at noon (after 11 a.m. service).
