IMPORTANT NOTES:

- 1) For families with more than ten (10) members, add \$4,180 for EACH additional family member.
- 2) The Miami-Dade County Ryan White Program Service Delivery Information System (SDIS) will be programmed according to these guidelines, effective March 1, 2017 through February 28, 2018.
- 3) Ryan White Program clients whose gross household income falls between 251% and 400% of the Federal Poverty Level (Column F above) may only receive Ryan White Program-funded outpatient/ambulatory health services, AIDS pharmaceutical assistance (local pharmaceutical assistance program), oral health care, medical case management, mental health services, substance abuse outpatient care, substance abuse services (residential), health insurance assistance, and outreach services. Persons with a gross household income above 400% FPL are not eligible for Ryan White Program services in Miami-Dade County.
- 4) Percentage calculations in the table above are rounded to avoid gaps between whole number dollar amounts.
