### New FDA Information on OraQuick In-Home HIV Test

The U.S. Food and Drug Administration (FDA) has published new information on the OraQuick In-Home HIV Test. This is the only FDA-approved in-home HIV test.

# Albertsons Companies and Walmart Donate Dispensing Services to HHS to Support the EHE Initiative

HHS will further expand access to pre-exposure prophylaxis (PrEP) HIV prevention medications by adding donated dispensing services from Albertsons Companies and Walmart to the Ready, Set, PrEP program beginning no later than July 30, 2020. The program allows uninsured patients to fill their prescriptions at no cost.

### FDA Approves New Drug to Treat Infants/Children with HIV

On June 12, 2020, the FDA approved Tivicay (dolutegravir) tablets and Tivicay PD (dolutegravir) tablets for suspension to treat HIV-1 infection in pediatric patients at least four weeks old and weighing at least 3 kg (6.61 pounds) in combination with other antiretroviral treatments.


