



UPDATED January 2021 Suspension of the ADAP Requirement for CD4 and Viral Load Labs State of Florida Governor's Executive Order 20-316 extends the previous Executive Order No. 20-52 for another 60 days: This means that the suspension of the ADAP requirement for CD4 and Viral Load labs at enrollment and recertification will be extended to February 26, 2021.
