# I. Call to Order/Roll Call

Susy Martinez, CQM coordinator, called the meeting to order at 9:33 a.m.

# II. Roll Call

Members noted their presence by indicating "Here" or "Present" in the chat box.

#### III. Review Agenda & Minutes

The committee reviewed today's agenda and the meeting minutes from September 21, 2021. No changes were made, both items were approved. Next steps from the last meeting minutes were reviewed.

#### IV. Show me the Data! Drilling Down on the Data-

Dr. Robert Ladner

Dr. Robert Ladner presented Show me the Data! Drilling Down on the Data (copy on file). He reviewed the four steps of drilling down data that include:

**Step 1**-Identifying patients who are not retained.

Step 2-Assessing reasons for non-retention.

**Step 3**-Creating a table that includes reasons not retained.

Step 4-Developing a targeted follow-up plan.

Dr. Ladner reviewed and discussed examples of quality improvement tools that would be useful when analyzing data:

**Run chart**- Demonstrates trends in data and requires a minimum of 10 data points.

**Pie Chart**-Used to sort data in categorical groups (i.e., race, gender, or age).

**Bar Chart**- Used to compare categories on an X and Y axis and identify differences.

**Checklist**-A simple tool that captures repetitive activities (number of action plan completed, reasons client did not show for PCP appointments).

Dr. Ladner offered to host an excel training to members interested in learning how to create the various tools in excel. Several CQM Committee members chatted in their interest for the excel training. Susy Martinez will follow-up with a training date as well as with sending out an excel tutorial cheat sheet to CQM Committee members.

A 4-question quiz was administered during the meeting (copy on file). Sixteen (16) out of (26) CQM Committee members participated in the quiz. Q#1, 56% answered correctly, Q#2, 88% answered correctly, Q#3, 38% answered correctly, and Q#4, 63% answered correctly.

#### V. Prioritizing Quality Improvement Projects-

Dr. Robert Ladner

Dr. Ladner reviewed with the CQM Committee members that BSR CQM staff and the Recipient had a Technical Assistance (TA) call with Marlene Matosky, Chief – Clinical and Quality Branch, HAB/HRSA. Ms. Matosky reiterated during the TA call that Recipients should be conducting quality improvement activities for at least one funded service category at any given time.

Dr. Ladner recommended that the CQM Committee prioritize MCM clients who are not virally suppressed. He explained that viral load is a performance measure that can be measured every 6 months as opposed to retention- in-medical care that takes 12 months to

measure. CQM Committee members chatted in that they agreed with prioritizing viral load suppression for quality improvement activities.
