2013 Ryan White Demographic Summary

Petra Brock-Getz

Petra Brock-Getz gave a presentation on Ryan White Program Demographics from Year 23 (copy on file). There are 9,624 clients in care which is a 1% increase from last year. There are 1,332 new to care clients comprising 29% of all the clients in care and is the highest level in five years.

2013 Ryan White Program Utilization

Petra Brock-Getz

Petra Brock-Getz reviewed the YR 22 Services Utilization data (copy on file). Median and max cost per client were reviewed for all the services including the top ten's by cost and clients for core services. Overall, \$20,956,338 was expended, with an average cost per client of \$2,178.

South Dade Data

Robert Ladner

Robert Ladner reviewed FY 23 Ryan White Clients Living in DOH Life Zone X and Where They Are Receiving Outpatient Medical Care and Case Management (copy on file). The clients living in Life Zone X comprise 4.5% of all the clients in Ryan White Care. Forty-seven percent receive Outpatient Medical Care and Medical Case Management in South Dade. There are numerous issues with the geographic area included limited social services, transportation and stigma. It was noted that while the Ryan White program does not have many funded providers in the area, there are other non-Ryan White funded providers. Substance abuse services are provided by Agape,

New Hope, Sembrando Flores and Fellowship House. A current Ryan White provider is attempting to subcontract for Outpatient Medical Care with physicians from Homestead Hospital.
