The U.S. Department of Health & Human Services (HHS) is inviting comments on the draft HIV National Strategic Plan for 2021-2025 (HIV Plan). HHS, through the Office of the Assistant Secretary for Health and its Office of Infectious Disease and HIV/AIDS Policy, is coordinating the development of this plan with federal partners from six federal departments and 12 HHS agencies and offices.

NIH Announces Restructured HIV Clinical Trials Networks

The National Institute of Allergy and Infectious Diseases (NIAID), part of the National Institutes of Health, announced [on November 30] the clinical investigators and institutions that will lead four NIH HIV clinical trials networks over the next seven years to conduct the innovative, efficient clinical research needed to accelerate progress against the HIV pandemic. NIAID also awarded grants to 35 U.S. and international institutions selected as HIV clinical trials units. NIAID and co-funding NIH Institutes intend to provide approximately \$375.3 million in the first year to support the networks.
