## IV. AIDS Healthcare Foundation's (AHF) Best Practice

Neil Walker

#### **Best Practice Showcase**

Neil Walker presented Care Management Team Best Practice in Care (copy on file). Mr. Walker reported that the disease case managers at AHF are all licensed registered nurses. The disease case managers collaborate with a team that includes outpatient ambulatory health providers, Peers and other team members involved in the client's care. An acuity scale is used to determine the level of contact for clients and the specific needs of the clients.

# V. <u>Clinical Quality Management Performance Report Card</u> <u>Cycle Cycle 3</u>

Frank Gattorno

Frank Gattorno presented the Clinical Quality Management Performance Report Card Cycle 3 summary (copy on file). He highlighted the following: The number of Medical Case Management (MCM), Outpatient Ambulatory Health Services (OAHS), and Oral Healthcare (OHC) clients served in the Ryan White Program increased in quarter 3. The care continuum variables in medical care, retention in medical care, percent virally suppressed, and non-missing viral load decreased slightly in December 2022. The OAHS service category suppression and retention in medical care remains steady.

Mr. Gattorno quizzed the CQM Committee attendees on their post-knowledge of his presentation. Poll results are listed below:

- Q1 The CQM Performance Report Card results data highlights that from qtr. 2-3 the number of clients for OAHS, MCM and OHC categories increased, decreased, or remained the same? 75% answered correctly.
- Q2 Which continuum of care indicator consistently had the lowest percentage among the continuum of care series? in medical care retention in care, retention in medical care, suppressed viral load and non-missing viral load? 65% correctly.
- Q3 The MCM service category viral load suppression rate was consistently higher than the OAHS viral load suppression rate True or False? 75% answered correctly.

### VI. Minority AIDS Initiative Population Best Practice

Susy Martinez reviewed the Bilingual and Bicultural care team CQII intervention (Target HIV Best Practice Compilation: (copy on file), targeting Hispanic/Latina(o/x) client populations. The intervention provides culturally responsive care and connections to resources tied to their community and ethnicity, aimed to address, and reduce disparities in healthcare.
