Please **do not** use these terms . . .
Dirty . . . Clean . . . Full-blown AIDS . . . Victim . . .

▪ Ready 4 Life Program

Michelle Morales and Jennifer Williams from Hope for Miami, and Julie Stellmann and Derrick Forney from Behavioral Science Research Institute presented on the Ready 4 Life Program, including the project goals, training modules, number of participants, participant feedback, and statistics relative to HIV and sexual health education.

IX. Open Discussion and Announcements

Staff announced the Empower U Community Health Center National Black HIV/AIDS Awareness Day event, Melanated, Motivated & Moving Forward, taking place on March 28, 2023.

Luigi Ferrer, Florida Department of Health, announced the Miami Speaker's Bureau is accepting new members. Members will learn the tools needed to share their personal stories in order to educate others on HIV and sexually transmitted infection (STI) prevention, treatment and adherence.

Mr. Ferrer advised members of a Centers for Disease Control and Prevention health alert about shigella and the risks to people with HIV, specifically men who have sex with men.

Staff advised an alert was emailed from the County on the need to screen for congenital syphilis during pregnancy as there has been a dramatic rise in cases from 2017-2021.

Flyers about all announcements were posted at the meeting and made available online at www.aidsnet.org.

The meeting was suspended for a five minute break.
