

What is Ryan White Part B?

RWP Part B:

- Provides funds for medical and support services;
- Designates funds are to be used to improve the quality, availability, and organization of HIV health care and support services;
- Includes the AIDS Drug Assistance Program (ADAP);
- Is available to all 50 states, territories, and jurisdictions of the U.S.
- Provides funds to emerging communities with a growing epidemic, reporting 500-999 new cases in the past 5 years.

Contract Year: April 1 - March 31.

Administered by: FDOH-MDC.

Fundable Part B Services

- At least 75% of Part B funding must be spent on Core Medical Services.
- Locally funded Part B Core Medical Services:
 - Mental health services; and
 - Medical case management, including treatmentadherence services.
- No more than 25% of Part B funding can be spent on Support Services.
- Locally funded Part B Support Services:
 - Non-medical case management;
 - Emergency Financial Assistance; and
 - Referral for Health Care/Support Services.



Why Understanding Part B Matters

- Part A is the payor of last resort.
- Just because services are not funded under Part A does not mean they are unavailable.
- By understanding other grantee funding, you get a better understanding of all available services.



The AIDS Drug Assistance Program (ADAP):

- Is a component of Ryan White Part B.
- Provides FDA-approved medications to lowincome people with HIV; and
- Pays for health insurance premiums under the Affordable Care Act Marketplace (ACA-MP).
- ADAP funds are administered by the Florida Department of Health.
- Contract Year: April 1-March 31
- Administered by: FDOH-Tallahassee

Why Understanding ADAP Matters


- No one should ever be without HIV medication!
- People with HIV should have the peace of mind that their medication costs will not be a barrier to staying healthy.
- Insurance through ADAP may provide people with HIV a broader range of available services.

Key Take Aways

Part B has similar funding restrictions to the Part A Program in terms of core and support services.

Part B provides several services different from Part A.

ADAP is a component of Part B and covers prescriptions and insurance premiums.





Ryan White Part C

Ryan White Part C:

- Is funded under the "Early Intervention Services and Capacity Development Program Grant"; and
- Provides funds for a variety of early intervention and care services.

Contract Year: Varies by grantee

Administered locally by four grantees:

- 1. Borinquen Health Care Center
- 2. Empower U
- 3. Miami Beach Community Health Center
- 4. University of Miami

Ryan White Part D

Ryan White Part D:

Funds support services to women, infants, children, and youth.

Contract Year: January 1 – December 31


Administered locally by: University of Miami-OB/GYN.

Key Take Aways

Part C and Part D funds go to individual agencies that fund a variety of services.

Part D funds target a specialized demographic: women and children (0-24 years old).





General Revenue

General Revenue:

- Funds various medical and support services; and
- Funds several services not covered under the Ryan White Program: Nursing Home Care and Home Health Care, for example.

Contract Year: July 1 - June 30

Managed by: The South Florida AIDS Network (SFAN) located at Jackson Memorial Hospital (contracted by FDOH).

Medicaid

State Medicaid:

- Provides a variety of medical and support services.
- Covers individuals who are Florida residents, "U.S. nationals, citizens, permanent residents, or legal aliens, in need of health care/insurance assistance, whose financial situation would be characterized as low income or very low income."

Contract Year: October 1 to September 30

Administered by: Agency for Health Care Administration (ACHA).

HOPWA

Housing Opportunity for Persons with AIDS (HOPWA):

- Provides housing assistance (long term, project based, STRMU) for individuals with HIV/AIDS and their families.
- Provides housing specialist (non-medical case management).
- Funded through the U.S. Department of Housing and Urban Development (HUD).

Contract Year: October 1-September 30

Administered by: The City of Miami.

Ryan White Part F

Part F has three components:

- AIDS Education and Training Centers
- Dental Programs
- Special Project of National Significance (SPNS)

Local Health Department -Prevention


The Florida Department of Health in Miami-Dade County:

- Local Health Department;
- Provides prevention services;
- Facilitates specific prevention commnity groups;
- Drives the Prevention Committee agenda; and
- Is the lead on Integrated Plan Prevention activities.

Key Take Aways

Federal programs like Medicaid are the largest providers of services.

Some grantees offer targeted services e.g., HOPWA (housing) and FDOH-MDC (prevention); and some offer services different from Part A.





Why Other Funders Matter?

- Ryan White legislation requires that other funders participate in the planning council.
- There are many services available outside the Ryan White Part A Program to benefit people with HIV.
- Knowing if funds are available for services means knowing where to go or where to direct someone in need.
- Knowing who your Partnership member contact is means you have a point person to guide you in better understanding the entire service system.




Why Understanding Funding Matters

- Partnership members are responsible for allocating more than \$27 million of Part A/MAI funding every year.
- By knowing about other available funds, you can make informed decisions about the distribution of Part A/MAI funds.
- And remember, Part A is the payer of last resort so look for those Part B, ADAP, and GR funds as the first line of funding!
