# Thriving with HIV 2024 Roundtable Series: *Develop Your 10-minute HIV 101 and Partnership 101 Elevator Pitch*

Member Luigi Ferrer led attendees in a discussion of how to speak about HIV, the difference between HIV and AIDS, modes of transmission, and current promotion messaging. Attendees discussed the importance of promoting Pre-Exposure Prophylaxis (PrEP), condom usage, stressing that HIV is not a "death sentence", and allowing themselves to accept that HIV is just something in their lives. Members discussed the Undetectable Equals Untransmittable (U=U) prevention messaging and stressed that this is not applicable to all sexually transmitted infections and therefore condom usage should still be promoted. Attendees also discussed how messaging should be tailored to different audiences and that over-explaining could be detrimental to messaging.

Staff noted the activity handout in member packets included a brief elevator pitch for the Partnership and encouraged everyone to commit this to memory.

The information and feedback from tonight's activity will be incorporated in next month's activity on developing a personal role model story.
