

Ending the HIV Epidemic (EHE) Housing Providers

Good afternoon,

Our office funds the three (3) subrecipient (service provider) organizations listed below to provide EHE Housing Stability Support (HSS) services. The main programmatic contacts are indicated but other agency staff may be providing the actual services to clients.

Miami-Dade County's EHE-funded HSS services utilize a "housing is healthcare" and housing-first approach to provide transitional, short-term, or emergency housing assistance to enable a client or family to gain or maintain critical outpatient / ambulatory health services and treatment, including temporary assistance necessary to prevent homelessness and to gain or maintain access to medical care. Services include rental and utility subsidies, moving incidentals, linkage to additional services, vocational and life skills support, and case management to develop and implement a plan to ensure ongoing housing stability by improving opportunities to increase client income through employment or access to SSI/SSDI Outreach, Access and Recovery (SOAR), securing permanent tenant based rental assistance, or placement in permanent supportive housing). HSS will be provided to EHE program-eligible individuals experiencing homelessness or housing instability for up to 24 months from each client's enrollment, subject to available funding. The only eligibility requirement is that the client has a confirmed HIV diagnosis.
