Please **do not** use these terms . . .

Dirty . . . Clean . . . Full-blown AIDS . . . Victim . . .

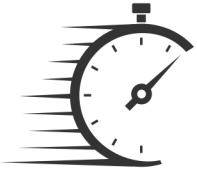

I. Call to Order

Virginia Muñoz, Prevention Committee Chair, called the meeting to order at 10:14 a.m.

II. Introductions

Ms. Muñoz called for introductions of members and guests.

III. Housekeeping

Ms. Muñoz presented the Housekeeping PowerPoint which includes general reminders, code of conduct, people first language, and meeting participation best practices.

IV. Floor Open to the Public

VII. Reports

▪ **Membership**

- **Partnership Report to Committees**

The Partnership has not met since the last Prevention Committee meeting. The Partnership report is posted online. The next scheduled meeting of the Partnership is May 13, 2024, at the Miami-Dade County Main Library. Ms. Muñoz reminded attendees to please RSVP.

VIII. Standing Business

- **State Integrate Plan Update**

Ms. Muñoz advised that this was the final day to give feedback on the *2022-2026 State of Florida Integrated HIV Prevention and Care - Monitoring and Evaluation Plan*. Members had received a copy of the Evaluation Plan by email which indicated the crosswalk between the State Integrated Plan and the Miami-Dade County Integrated Plan. Anyone wishing to provide additional feedback was asked to do so by the end of business today.

- **Miami-Dade County HIV Prevention Workgroup Reports**

Members heard brief updates on the latest Workgroup meetings, including recent and upcoming activities, presentations, and upcoming meeting dates for the Hispanic Initiative (Iniciativa Hispana); Transgender Tenacity Power; the Miami Collaborative MSM Workgroup; the Miami Speakers Bureau; and the Youth Health Committee.

IX. New Business

- **Special Presentations**

- The Infectious Disease Elimination Act (IDEA Exchange): T-SHARP Study**

Chad Fernandez, Prevention Committee Member and IDEA Exchange Outreach Coordinator; and Jimmie Brooks, IDEA Exchange Outreach Coordinator, presented *Project T-SHARP - Telehealth Solution to HIV and Addiction-Related Problems Among People Who Inject Drugs*. The presentation detailed the IDEA Exchange's harm reduction services available to people who inject drugs, whose services emphasize meeting people where they are, both physically and psychologically. Services at the fixed site, mobile units, and the medication management program were discussed. Mr. Fernandez and Mr. Brooks also discussed the Project T-SHARP Tele-Harm Reduction study, including qualifying criteria, expectation for participation, and assessment. Their contact information was shared in case anyone needed additional information.

- HIV Prevention Trials Network (HPTN) 096: Building Equity Through Advocacy: Testing an innovative community-informed, HIV status-neutral integrated strategy that aims to address social, structural, institutional, and behavioral barriers to HIV prevention and care for Black men who have sex with men**

Dr. LaRon E. Nelson, HPTN 096 study co-chair, Independence Foundation Professor of Nursing and Associate Dean of Global Affairs and Planetary Health, Yale School of Nursing; and Elizabeth Greene, Senior Clinical Research Manager, HIV Prevention Trials Network (HPTN) Leadership and Operations Center at FHI 360, presented information on HPTN 096. The pilot study began in 2022 and is now expanding to five U.S. communities, including Ft. Lauderdale/Miami. The study intends to address the growing incidence of HIV among Black/African-American men who have sex with men, and the disproportionately low use of pre-exposure prophylaxis (PrEP) among the same group. The strategy to engage participants includes four components: health equity, social media, peer support, and CRISP (Culturally Responsive Intersectional Stigma Prevention). HPTN 096 is identifying prevention and

treatment facilities for the study. Dr. Nelson, Ms. Greene and other representatives from the study were available after the meeting to connect with local providers.

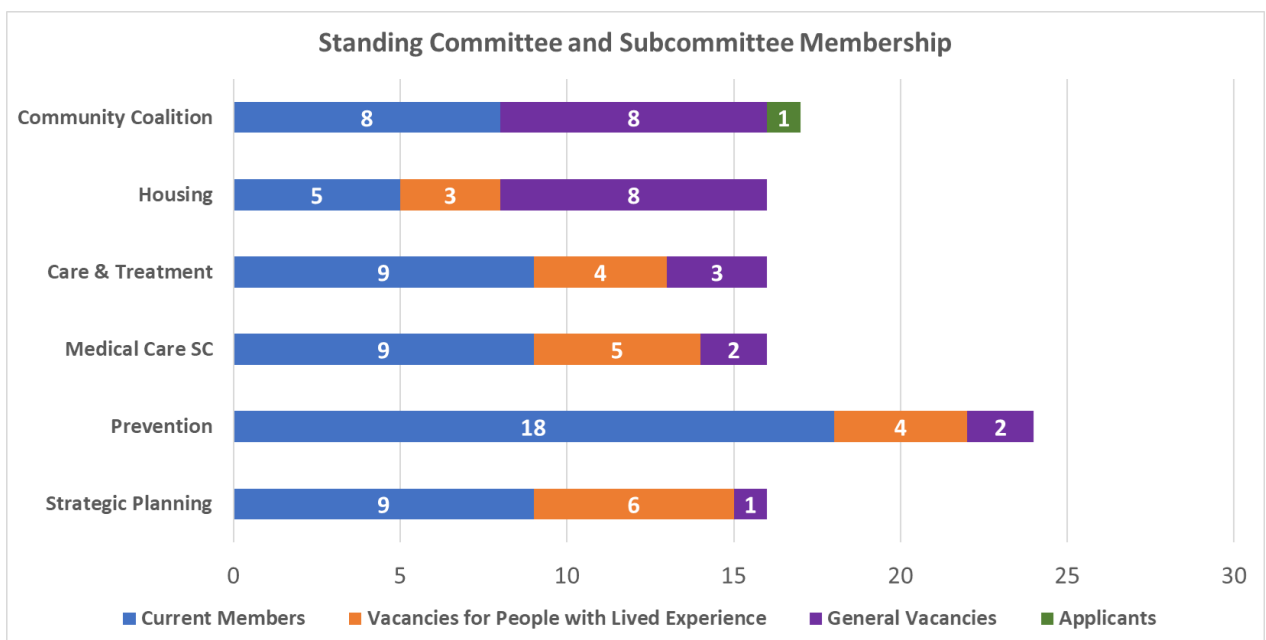
